Dear St. Paul's Families:

The After Care staff is looking forward to a great year with your children! If your child will be using After Care, please note that pre-payment through the FACTS system is required. (***No pre-payment is required for Baby and Toddler Saints.***) Please make your initial deposit by **August 13**, After Care services will begin for Kindergarten – 8th grade on **Thursday, August 13**. After Care will be available for Baby Saints – 8th grade on **Monday, August 17**.

To set up your After Care account:

- Log in to your FACTS account.
- You'll see two sections: one for your Tuition Payment Plan and one labeled Pre-Pay Account.
- Make an initial deposit of \$250.00 into your Pre-Pay Account.
- As you use After Care, charges will be automatically deducted by the Business Office.
- When your account balance drops below \$50.00, you'll receive a notification to add funds. Please deposit an additional \$200.00 at that time.

At the end of the year, any remaining credit can either be carried over to the next school year or refunded upon request.

After Care Hours:

Monday – Thursday 3:30 PM - 5:30 PM

Friday 2:45 PM - 5:30 PM

After Care Cost:

\$13.00 per hour (charged in 30 minute increments)

\$15.00 late fee for every 10 minutes after closing

Please be mindful that our After Care staff is scheduled to leave promptly at 5:30 PM. Late pick-ups not only result in late fees but also affect our staff members personally. We recommend allowing yourself an extra 5–10 minutes to account for any unexpected delays. If it is determined that you have been late on several occasions over a period of time, you may be informed that After Care services are no longer available for your child.

Pick-Up Procedure:

- Little Saints – Pre-K will dismiss from Gate 3 (Vicksburg Street at the Dunn Bldg.)
- Kindergarten – 8th Grade will dismiss from Parking Lot Pedestrian Gate (Gate 5)
- On inclement weather days, Kindergarten – 8th will dismiss from O'Ferrall Hall (Gate 1)

If you have to send someone not on the authorized list to pick up your child, please email Lauren ahead of time at lbrennan@stpauls-lakeview.org and call 504-453-0267. Let that newly authorized pick-up person know that he/she must show a photo ID in order to check the child out. We are looking forward to a great year in After Care.

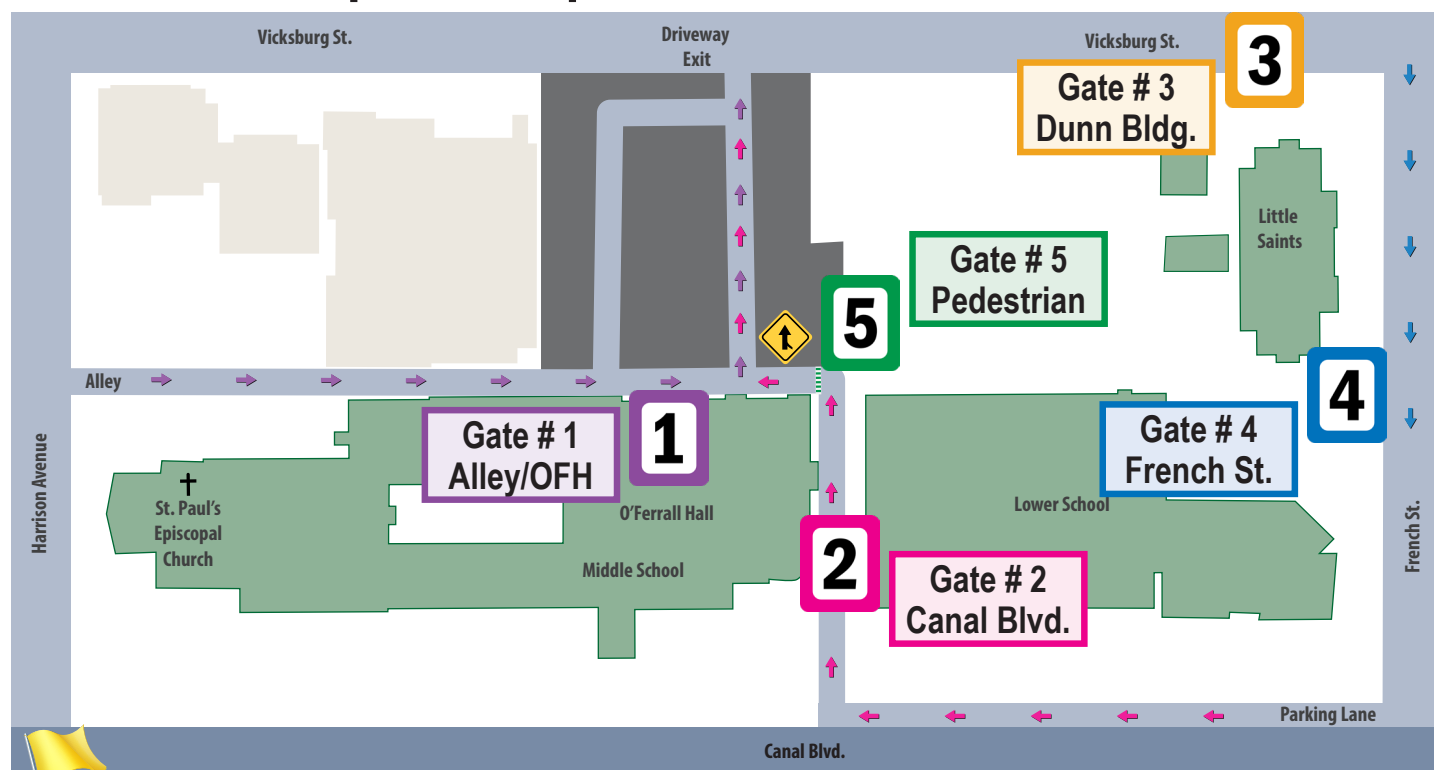

Rainy Day Drop-Off: Gate 4 will divert to Gate 2. See instructions for Gate 2. All other gates remain the same as non-rainy days.

Drop-Off Map Gate Details

Gate #1: Alley/O'Ferrall Hall

Enter through the alley on Harrison Ave to the O'Ferrall Hall doors. Traffic will yield and merge with traffic from Gate 2 and exit on Vicksburg. We ask that you not turn right on French to avoid our families using Gate 4.

Gate #2: Canal Blvd.

Enter from Canal Blvd. Please drive North on Canal Blvd, enter the blacktop gate and proceed between the lower and middle school buildings, heading in the direction of Vicksburg. Middle school teachers will greet students on the left. Lower school teachers will greet students on the right. For Baby Saints, it will be best to have your child's car seat behind the driver's seat. For safety, please have all children exit the vehicle closest to the building of your lane. There are two lanes of traffic, and we do not want children exiting cars in the middle. Traffic will yield and merge to the alley traffic and exit on Vicksburg. We ask that you not turn right on French to avoid our families using Gate 4.

Gate #3: Little Saints Dunn Bldg.

Corner of Vicksburg and French. Drop-off time is between 7:30AM-8:30AM. Children must be walked to the first door of the Dunn building.

Gate #4: French St.

The drop-off location is on French St., just past the Dunn Building. Please drive West on French. On rainy days, a yellow flag will be posted to denote that it is rainy day drop-off. On rainy days, you will drop-off at Gate 2.

Gate #5: Parking Lot (Pedestrian)

For **after hours access only**, please park and use the parking lot pedestrian gate to enter campus. This includes all sporting events, after hours club events, and pick-up from After Care.

Please be sure to see map details for each gate and note that your assigned gate may have changed from last year.
